

Notification under the Protection of Personal Data Act

As Marmara Capital we protect personal information in accordance with the laws and regulations of the related laws and regulations, taking all kinds of physical and electronic precautions and obeying the rules and practices we are obliged to comply with. In this respect, Marmara Capital has the capacity to act as a data responder in accordance with the Law on the Protection of Personal Data (Law No. 6698) and the legislation related to this Law. You are to obtain, record, store and keep all kinds of information ("personal data") belonging to your personal information acquired / shared or shared with our Institution by our Institution and processed by our Institution in the form prescribed in the below-mentioned and mentioned blood, we will inform you that any processing performed on your information, including changing, disclosing, transferring, making it available, means "processing personal data". Personal data collected by these methods can also be processed and transmitted to the purposes specified in the personal data processing conditions and purposes stated in Articles 5 and 6 of Law No. 6698.

Your personal data; It can be collected verbally, in writing or electronically by Marmara Capital representatives to store information such as identification, address, tax number and other information to be used in all kinds of products and services to be presented to you within the scope of the Capital Markets Law and relevant legislation and to determine the information of the owner and owner of all transactions and transactions to be performed, to comply with the obligations of information storage, reporting and information provided by all judicial and administrative competent authorities in accordance with the relevant legislation, to present our other products and services requested and requested by our organization, and to fulfill the requirements of our contract.

Your personal data, which are included in our Institution with the purposes listed above, Receiving personal data such as CMB(Capital Markets Board), BRSA (Banking Regulation and Supervision Agency) , CBT (Central Bank Of Turkey), ISE (İstanbul Stock Exchange), CSD (Central Securities Depository Of Turkey), Settlement and Custody Bank, TCMA (Turkish Capital Markets Association), Turkish Employment Agency, Capital Market Licensing Registry and Training Institution, Ministry of Finance, SSI, Foreign Service Providers, Public Banks with Agreed Banks investment institutions and other third persons determined by law no. 6362, including, but not limited to, the persons, institutions and / or institutions that the provisions of the Capital Markets Law numbered 6362 and other laws and other legislative provisions require / our main shareholder, our domestic / foreign subsidiaries; The capital market will be able to transfer to our partner, institution, institution, domestic / foreign investment institutions and other third parties that we are servicing, cooperating to carry out our activities. Personal data recorded by our company is protected by our Company. Our Company can not disclose the personal data which is known as Data Responsible and our employees in contradiction with the provisions of the Law and can not use it except for the purpose of processing.

The rights of our customers on the 11th article of the law are as follows. a) learning whether your personal data has been processed, b) requesting information if your personal data is processed, c) knowing whether your personal data is being used appropriately for the purpose and purpose of your work; d) knowing the third parties your personal data is transferred in / out of the country, e) request your personal data to be corrected if it is incomplete / incorrectly processed, f)requesting that your personal data be deleted / destroyed within the framework of the conditions laid down in Article 7 of the Law, g) requesting the third parties to whom your personal data is transmitted to be notified of the actions taken in accordance with subparagraphs (e) and (f) above h) you have the right to object to the fact that your personal data is analyzed exclusively by automated systems, and i) you have the right to claim damages in case you are harmed because of your personal data being processed in contravention of the law.

Your rights in this context can be obtained by applying to our Agency under the conditions stipulated in the Law No. 6698 and you can learn the rights stated in your personal data and request information.
